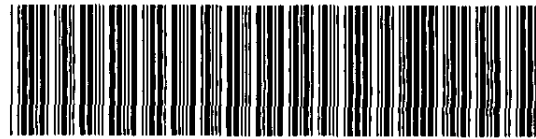

5. The Limited Liability Company is to be Manager-Managed. The name of the initial Manager is: Fauna Investments Services Ltd

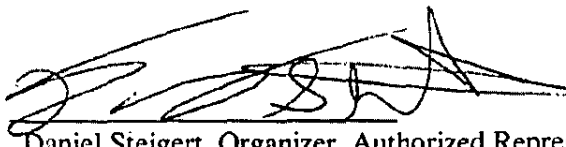
6. The limited liability company will be organized for any and all purposes permitted under Florida Law.
