



AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF CHANTY LAUREN, LLC

The undersigned hereby submits these Amended and Restated Articles of Organization ("A/R Articles of Organization") which amends and restates in the entirety those Articles of Organization filed April 24, 2014 ("Original Articles of Organization") of Chanty Lauren, LLC, a Florida limited liability company, and the same is submitted under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, to be made effective as of the date of filing.

ARTICLE I - Name
