**ARTICLES OF ORGANIZATION
OF
CANDELARIO CONSTRUCTION SERVICES, LLC**

The undersigned hereby forms a limited liability company with the meaning of the applicable provision of Chapter 605 Florida Statutes.

**ARTICLE I
NAME**

The name of this limited liability company **CANDELARIO CONSTRUCTION SERVICES, LLC** (the "Company").
