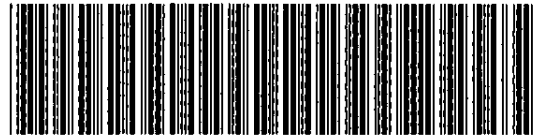

Of

ARTICLE IV


Management of the Company shall be vested in the members as provided in the Operating Agreement of the Company.
