The undersigned authorized representative, desiring to restate the articles of organization as authorized by Section 605.0202 of the Florida Statutes, hereby submits, and files with the Florida Department of State, these Restated Articles of Organization.

**ARTICLE I - Name**

The name of the limited liability company previously created (hereinafter, the "Company") is:

To the extent permitted by the Company's operating agreement, additional members may be admitted in the manner provided by the Company's operating agreement.


**ARTICLE VIII - Ownership**


