RESTATEMENT OF ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

The undersigned authorized representative, desiring to restate the articles of organization as authorized by Section 605.0202 of the Florida Statutes, hereby submits, and files with the Florida Department of State, these Restated Articles of Organization.

ARTICLE I - Name

All membership units then issued shall be paid for and shall be non-assessable.
