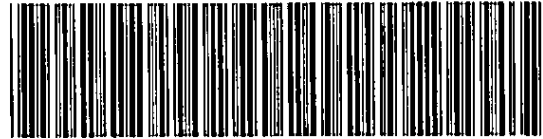


Agreement/General Release


Jill G. Fine agrees to remove herself as a Managing Member of BrownBag Popcorn Co., LLC, a Florida Limited Liability Company.
