**RESTATEMENT OF
ARTICLES OF ORGANIZATION
OF
PLATFORM CONTENT, LLC**

The Articles of Organization of Platform Content, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on May 2, 2014. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is Platform Content, LLC.

ARTICLE II - PRINCIPAL OFFICE
