ARTICLE I - NAME

ARTICLE VIII - AMENDMENT

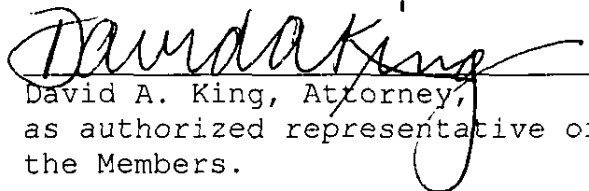

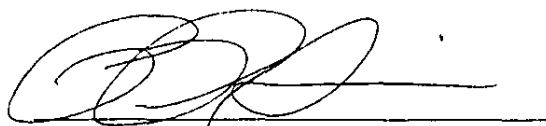
