Effective at 12:01 a.m. on the date of this filing, [REDACTED], a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby submit the following Articles of Organization pursuant to Section 605, Fla. Stat.

**ARTICLE 1****NAME**

**ARTICLE 2****DURATION**

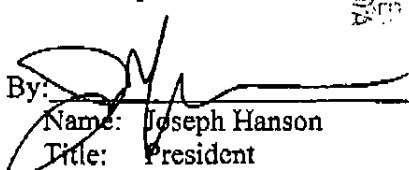

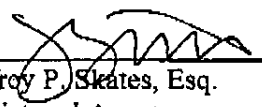
