The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, *F. S. Ch. 605*, hereby make, acknowledge, and file the following Articles of Organization:

ARTICLE I

The name of the limited liability company shall be **I-DEAL SELF STORAGE OF LAKE WALES, LLC** (the "Company").

ARTICLE II

The mailing address and the street address of the Company shall be **6443 E State Road 60, Lake Wales, FL 33853**.

ARTICLE III

The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV

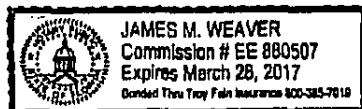
