**ARTICLES OF ORGANIZATION

Dumas and Marsha Dumas, natural persons competent to contract and members of Dumas Perdido Rentals, LLC, hereby present these Articles of Organization as the Articles of Organization of Dumas Perdido Rentals, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Dumas Perdido Rentals, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
