ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
MARISOL ARCILA, M.D., LLC

1. The Name of the limited liability company is: Marisol Arcila, M.D., LLC (the "Company").
2. The Company filed the Articles of Organization of the Company on May 8, 2014. The Articles of Organization document number is L14000078879.
3. The Company amends its Articles of Organization by changing its name to Marisol Arcila, M.D., PLLC. Article I of the Articles Organization is amended to change the name of the Company to Marisol Arcila, M.D., PLLC.
4. The Company also amends its Articles of Organization by adding Article VI. Article VI of the Articles of Organization reads as follows:

Article VI – Purpose:

The general purpose for which this professional limited liability company is organized shall be (i) to render healthcare services to the general public, and to do all things in connection therewith that are customarily done by medical doctors under the laws of the State of Florida and (ii) in furtherance of its corporate purposes, the professional limited liability company shall have all of the general and specific powers and rights granted to and conferred on a company by the Professional Services Limited Liability Company Act.

5. Except as amended hereby, the Articles of Organization shall remain in full force and effect.

These Articles of Amendment to the Articles of Organization were approved by the sole Member of the Company on June 11, 2014. The number of votes cast in favor of this Amendment was sufficient for approval.
