ARTICLES OF ORGANIZATION

OF

REAL ESTATE MACAYA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **REAL ESTATE MACAYA, LLC**, a limited liability company (the "Company").

ARTICLE II - ADDRESS

(a) The principal address of the Company shall be 850 North Miami Avenue, Unit W-405, Miami, FL 33136.

ARTICLE III - DURATION

The Company shall commence its existence on the date these articles of organization are filed with the Florida Department of State. The Company's existence shall be perpetual unless the company is earlier dissolved as provided in these Articles of Organization.

ARTICLE V - INITIAL MEMBERS

The Company shall have the following Initial Members. The membership interest, voting rights, rights to distributions and all other rights and duties of the members shall be set forth in and described in the Limited Liability Company Operating Agreement on file at the principal office of the Company (the "Operating Agreement"). The Initial Members and their designations are as follows:

ARTICLE VI -- CAPITAL CONTRIBUTIONS

The member(s) of the company shall contribute to the capital of the Company the cash or property set forth in and described in the Limited Liability Company Operating Agreement on file at the principal office of the Company (the "Operating Agreement").

Each member shall make additional capital contributions to the Company only on the consent of the member(s) as set forth in the Operating Agreement.

ARTICLE IX -- MANAGEMENT

The Company shall be managed by a manager or managers in accordance with the Articles of Organization, the Operating Agreement, the Regulations adopted by the member(s) for the management of the business and the ordinary and customary affairs of the Company. The Regulations and the Operating Agreement, if any, shall determine the manner in which such the Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the company not inconsistent with the law or these Articles of Organization. ARTICLE IX -- TERMINATION OF EXISTENCE

ARTICLE X -- INDEMNIFICATION


