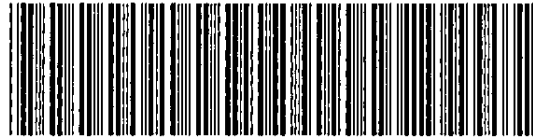

**ARTICLES OF ORGANIZATION OF
INSULVATION, L.L.C.**

The undersigned, desiring to form a limited liability company under the provisions of Sections 605.0101 *et seq.*, Florida Revised Limited Liability Company Act, as amended, hereby sets forth the following:

Article I. Name. The name of the Limited Liability Company is INSULVATION, L.L.C.

Article II. Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is 12485 2nd Street E., C-102, Treasure Island, FL 33706.

Article III. Registered Office and Agent. The post office address of the initial registered office of the Limited Liability Company is located within the City of St. Petersburg at 696 First Avenue North, Suite 201, St. Petersburg, Florida 33701. The initial registered agent is G. Barry Wilkinson, whose business address is the same as the post office address of the initial registered office, and who is a resident of Florida and a member of the Florida State Bar.
