

ARTICLES OF ORGANIZATION
OF
DIANA PATRICIA MARTIN, PLLC

The undersigned hereby certifies that he is the Authorized Representative of a Member who is forming a Professional Limited Liability Company under Chapter 621, Florida Statutes. The following Articles of Organization are hereby adopted.

I.ARTICLE
NAME

The name of the Professional Limited Liability Company shall be Diana Patricia Martin, PLLC.

II.ARTICLE
DURATION; EFFECTIVE DATE

This Professional Limited Liability Company shall first perpetually commencing as of May 6th 2014.

III.ARTICLE
