ARTICLE IV - DURATION



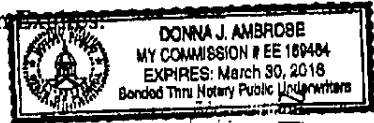
