The undersigned certify that we have associated ourselves together for the purpose of becoming a SELRE LARY OF STATE limited liability company under the laws of the State of Florida, providing for the following privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be THE GIVING TREE, LLC, and its principal office and mailing address shall be located at 2035 Gayle Place, Clearwater, Florida 33763, but it shall have the power and authority to establish branch offices at any other place of places as the members may designate.

5. To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.

6. 7.
