ARTICLES OF ORGANIZATION

OF

J & J HOME REPAIR AND PAINTING SERVICES LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **J & J HOME REPAIR AND PAINTING SERVICES LLC** ("Company").

ARTICLE 2 - ADDRESS

ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT



ARTICLE 9 - MANAGEMENT


