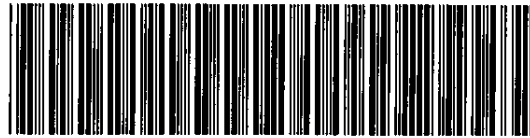

The initial registered office of this limited liability company is 215 North Federal Highway, Boca Raton, FL 33432. The initial registered agent at that address is James H. Batmasian.

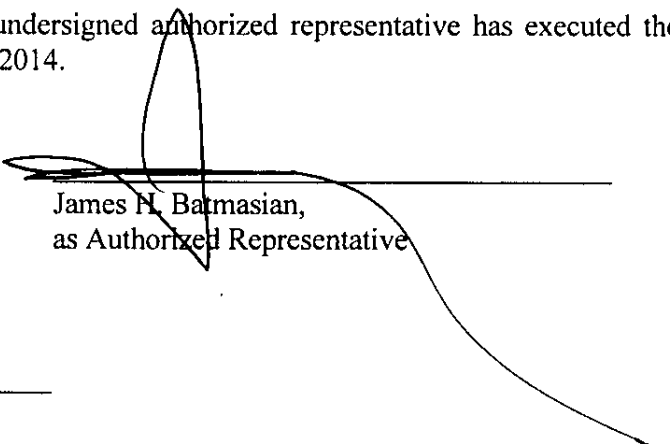
ARTICLE IV

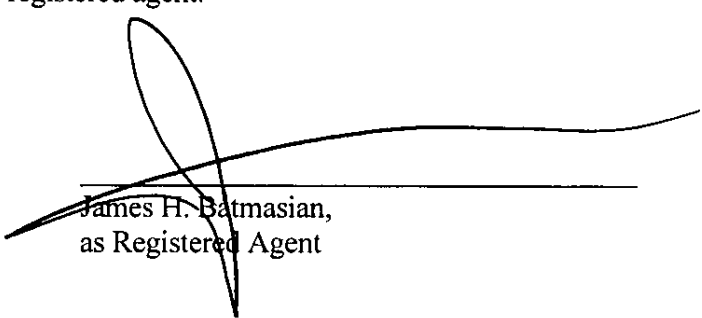
