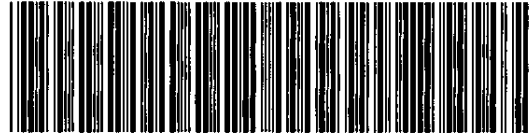

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of the Limited Liability Company shall be KREISER FARMS, LLC ("Company"). The mailing address and street address of the principal office of the Company is: 16844 On Par Boulevard, Fort Myers, Florida 33908.

ARTICLE II
DURATION

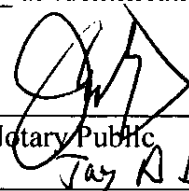

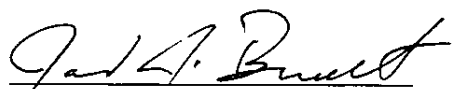
