The undersigned, STUDER COMMUNITY DEVELOPMENT, LLC, a Florida limited liability company authorized to contract and the sole member of STUDER INSTITUTE, LLC, hereby presents these Articles of Organization as the Articles of Organization of STUDER INSTITUTE, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is STUDER INSTITUTE, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
