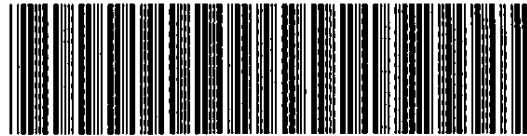

**ARTICLES OF ORGANIZATION**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I - Name:**

The name of the limited liability company (hereinafter referred to as the "Company") is GTMD Holdings, LLC.

**ARTICLE II - Address:**

**ARTICLE VII - Existence of Company:**

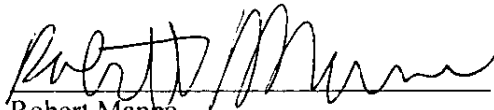
The existence of the Company shall commence on the date these Articles of Organization are signed.
