ARTICLES OF ORGANIZATION
OF

In accordance with the Florida Revised Limited Liability Company Act as set forth in Chapter 605 of the Florida Statutes, the undersigned Manager does hereby adopt the following Articles of Organization for TAX TRACK OF DELRAY, LLC (the "Company"):

ARTICLE I

NAME

The name of the Company is TAX TRACK OF DELRAY, LLC and its principal place of business shall be in the City of Delray Beach, County of Palm Beach, State of Florida, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE II

DURATION

MANAGEMENT

The Company is to be managed by one or more managers and is, therefore, a manager - managed company.

ARTICLE VI

INDEMNIFICATION

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.

The undersigned, being a Manager of the Company, hereby certifies that the foregoing constitutes the proposed Articles of Organization of TAX TRACK OF DELRAY, LLC.
