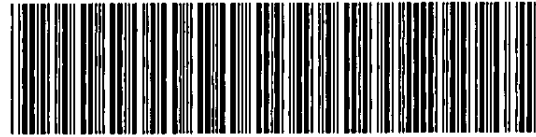

ARTICLES OF ORGANIZATION
OF
MIAMI 1 INTERNATIONAL REALTY, LLC

ARTICLE I - NAME

The name of the Limited Liability Company is MIAMI 1 INTERNATIONAL REALTY, LLC (the "Company").
