2. These Articles of Amendment are submitted to delete Article IV of the Articles of Incorporation in its entirety and substitute the following therefor:

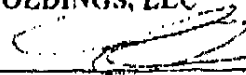

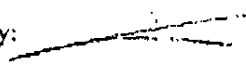
