**ARTICLES OF ORGANIZATION
OF
SOUTH FLORIDA GUARDIAN, LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Revised Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is South Florida Guardian, LLC (the "Company").

**ARTICLE II
ADDRESS**

The principal and mailing address of the Company is 2450 Hollywood Blvd., Suite 601, Hollywood, FL 33020.

**ARTICLE III
REGISTERED AGENT AND OFFICE**
