**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
STAYSKY REALTY, LLC**

The limited liability company was organized on June 5, 2014 under the name STAYSKY REALTY, LLC and issued Florida document number L14000090665. Pursuant to Sections 605.0201 and 605.0202, *Florida Statutes*, the Articles of Organization of STAYSKY REALTY, LLC (the "*Company*") are hereby amended and restated in their entirety to read as follows:

**ARTICLE I. NAME**

The name of the limited liability company is STAYSKY REALTY, LLC (the "Company").

**ARTICLE II. ADDRESS**

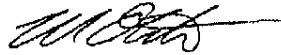
