ARTICLES OF ORGANIZATION

**First:** The Articles of Organization of Pics Enterprises LLC were filed with the Florida Secretary of State on June 5, 2014 and assigned Document Number L14000091038.

**Second:** Such Articles of Organization (the "Articles") are hereby deleted in their entirety and Amended and Restated as follows:

**ARTICLE I.  
NAME**

The name of the limited liability company is Pics Enterprises LLC (the "Company").

**ARTICLE II.  
MAILING AND STREET ADDRESS**

The mailing address and street address of the principal office of the Company shall be 1600 Ponce de Leon Boulevard, Suite 807, Coral Gables, Florida 33134.

**ARTICLE III.  
REGISTERED AGENT AND OFFICE**
