AMENDED ARTICLES OF ORGANIZATION

of

In accordance with the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, P AND Z PRODUCTIONS LLC hereby adopts the following amendment to its Articles of Organization, which were filed on June 5, 2014. The Articles of Amendment were duly adopted on November 1, 2015 by the required percentage of the Membership entitled to vote on the amendment.

ARTICLE I - NAME
