## **SECOND AMENDED ARTICLES OF ORGANIZATION**

of

### **P AND Z PRODUCTIONS LLC (Document No. L14000091051)**

In accordance with the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, P AND Z PRODUCTIONS LLC hereby adopts the following name change and amendment to its Articles of Organization, which were filed on June 5, 2014. These Articles of Amendment were duly adopted on June 1, 2016 by the required percentage of the Membership entitled to vote on the amendment.

#### **ARTICLE I - NAME**

The name of the limited liability company is hereby amended and shall be changed from P AND Z PRODUCTIONS LLC to PERFORMANCE SPORTSWEAR LLC, hereinafter referred to as the "Company".

#### **ARTICLE II - ADDRESS**

The principal street address and mailing address of the Company is 600 NE 27th Street, LHP-5, Miami, Florida 33137.

#### **ARTICLE III - PURPOSE**

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

#### ARTICLE VII – DURATION




