ARTICLES OF ORGANIZATION  
OF

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I  
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is MYRIAD ENTERPRISES, LLC

ARTICLE II  
ADDRESS

The Company's street address of its principal place of business in Florida is 4404 Devonshire Place, Pace, Florida 32571, and its mailing address is the same, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

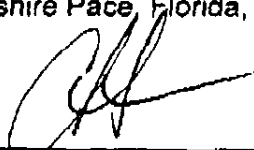
