## ATTACHMENT TO ARTICLES OF ORGANIZATION

## ARTICLE VI

- (a) Pursuant to s. 605.0304, Florida Statutes, and unless otherwise provided by law or expressly assumed, a person who is a member, shall not be liable for the acts, debts or liabilities of the limited liability company.
- (b) Except as otherwise provided in this Article, the limited liability company shall indemnify any member and may indemnify any officer, employee or agent of the limited liability company who was or is a party or is threatened to be made a party to a threatened, pending, or completed action, suit or proceeding, whether civil, criminal administrative, or investigative, and whether formal or informal, other than an action by or in the right of the limited liability company, by reason of the fact that such person is or was a member. employee or agent of the limited liability company against expenses, including attorney fees, judgments, penalties, fines and amounts paid in settlement actually and reasonably incurred by such person in connection with the action, suit or proceeding, if the person acted in good faith, with the care an ordinarily prudent person in a like position would exercise under similar circumstances, and in a manner that such person reasonably believed to be in the best interests of the limited liability company and with respect to a criminal action or proceeding if such person had no reasonable cause to believe that such person's conduct was unlawful. To the extent that a member, employee, or agent of the limited liability company has been successful on the merits or otherwise in defense of an action, suit or proceeding, or in defense of any claim, issue or other matter in the action. suit or proceeding, such person shall be indemnified against actual and reasonable expenses, including attorney fees, incurred by such person in connection with the action, suit or proceeding and any action, suit or proceeding brought to enforce the mandatory indemnification provided herein. Any indemnification permitted under this Article, unless ordered by a Court, shall be made by the limited liability company only as authorized in the specific case upon a determination that the indemnification is proper under the circumstances because the person to be indemnified has met the applicable standard of conduct and upon an evaluation of the reasonableness of expenses and amounts paid in settlement. Notwithstanding the foregoing to the contrary, no indemnification shall be provided to any member, employee or agent of the limited liability company for or in connection with the receipt of a financial benefit to which such person is not entitled, voting for or assenting to a distribution to a member in violation of the Florida Revised Limited Liability Company Act, or a knowing violation of law. The foregoing shall not be inconsistent with Florida Law.

### ARTICLE VII

An assignee of a membership interest in the limited liability company may become a member only in accordance with a written operating agreement between or among the members and an agreement between the member(s) and the assignee.

#### ARTICLE VIII

The limited liability company shall be managed by a manager.
