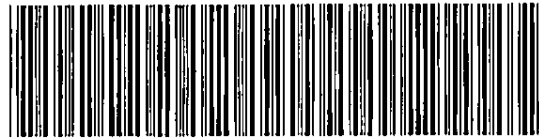

FIRST: The Articles of Organization of the Company were filed on June 10, 2014, and assigned Florida document number L14000092895.

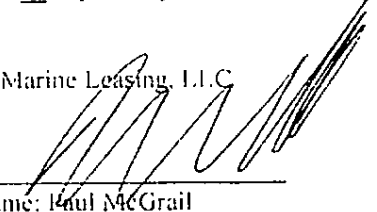
SECOND: The Articles of Organization of the Company are hereby amended as follows:
