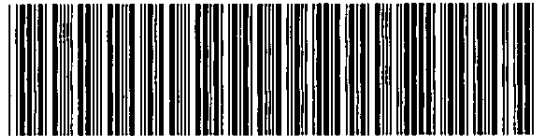


ARTICLE VI – STATEMENT OF AUTHORITY
