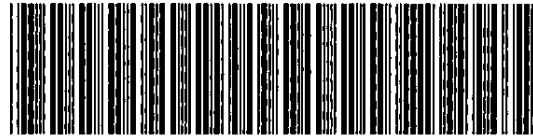

ARTICLE I - NAME

The name of the limited liability company shall be **MJM&M INVESTMENTS, LLC**.


ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND ADDRESS


ARTICLE VII - CONTINUATION OF BUSINESS
