

ARTICLES OF ORGANIZATION OF CONQUISTA REAL ESTATE, LLC

Pursuant to the provisions of Chapter 605 of the Florida Statutes (the "Florida Revised Limited Liability Company Act"), the undersigned representative of the managers, for the purposes of forming a Florida limited liability company, hereby adopts the following Articles of Organization:

ARTICLE 1 NAME

The name of the company is CONQUISTA REAL ESTATE, LLC (the "Company").

ARTICLE 2 DURATION AND PLACE OF BUSINESS

The period of duration of the Company is perpetual and its principal place of business is at 17315 Collins Avenue, Unit 1805, Sunny Isles, Florida 33160.
