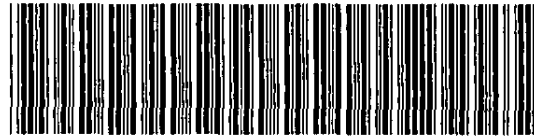

The undersigned hereby submits these Articles of Organization ("*Articles of Organization*") of EasyRent.Com, LLC, a Florida limited liability company, and the same is submitted under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, to be made effective as of the date of filing.

ARTICLE I - Name

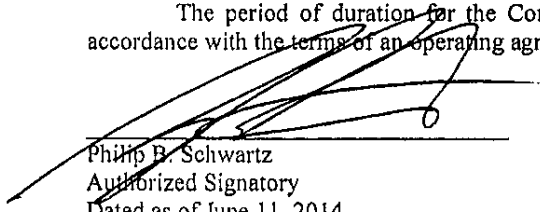
