**ARTICLES OF ORGANIZATION  
OF  
NITMOI, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I**

Name. The name of the limited liability company shall be NITMOI, LLC ("Company").

**ARTICLE II**

Address. The mailing address and street address of the principal office of the Company shall be 4545 Old Carriage Trail, Oviedo, Florida 32765.

**ARTICLE III**






