ARTICLE I Name of Limited Liability Company

The name of this limited liability company is ACQUISITION CONSULTANTS PROPERTY MANAGEMENT, LLC (the "Company"), with its principal place of business being located at 720 East Colonial Drive, Orlando, Florida 32803 and the mailing address is the same.

ARTICLE II Duration

The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of fifty (50) years from the date of filing or the occurrence of any of the events specified in Chapter 605, Florida Statutes, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III Purpose

ARTICLE VII Management of the Company

ARTICLE X Transfer of Interest

No member shall have the right to transfer any interest in the Company without the unanimous written agreement of all members. If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring members shall have no right to become a member or to participate in the management of the business and the uffairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

ARTICLE XI
Certificated Interests

The members' interests in the Company shall be evidenced by certificates.
