**ARTICLES OF ORGANIZATION
OF
MIL & ROSS USA, LLC**

The undersigned, being a duly authorized representative of the members, desiring to form a limited liability company under and pursuant to the revised Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopts the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is MIL & ROSS USA, LLC (the "Company").

ARTICLE II

ADDRESS

The principal office and mailing address of the Company is: 20801 Biscayne Blvd. Suite 403, Aventura, Florida 33180.

ARTICLE III

REGISTERED AGENT AND OFFICE

The Company designates: 20801 Biscayne Blvd. Suite 306, Aventura, Florida 33180, as the street address of the initial registered office of the Company and names Oscar Grisales Racini, as the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE IV

DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, or (ii) by the written agreement of a majority of ownership interest.

ARTICLE V

PURPOSE

The purpose for which the Company is being formed is to engage in the holding, investment, ownership, operation and management of underlying entities and/or businesses, and to further undertake any lawful commercial enterprises, and any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE VI

MANAGEMENT

The Company shall be conducted, carried on, and managed by a manager(s) and is, therefore, a manager(s)-managed Company.

ARTICLE VII

INITIAL AND ADDITIONAL MEMBERS

Unless otherwise provided in the Company's Operating Agreement, the maximum number of ownership units which the Company is authorized to have outstanding is one hundred (100), all of which shall be identical units, and each of which shall represent the ownership of that percentage of the total units outstanding at any time as is the equivalent of the ratio in which one (1) is the numerator and the total units outstanding is the denominator.


Additional Members may be admitted in the manner set forth in the Operating Agreement of the Company.

ARTICLE IX

OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Manager (s) of the Company in the manner set forth in the Operating Agreement of the Company.
