AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF ADVENIR@LOWRY, LLC

Original Articles of Organization filed with the Florida Department of State on June 18, 2014 [Document Number L14000098280]

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Amended and Restated Articles of Organization (the "Articles").

ARTICLE I NAME

The name of the limited liability company is Advenir@Lowry, LLC (the "Company").

ARTICLE II MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 17501 Biscayne Boulevard, Suite 300, Aventura, Florida 33160.

ARTICLE III REGISTERED AGENT AND OFFICE

The name and street address of the initial registered agent of the Company in the State of Florida is Torres Law, P.A., 888 Southeast 3rd Avenue, Suite 400, Fort Lauderdale, Florida 33316.
