ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE 1 - NAME

Real Estate Investments, Imports and Exports.

ARTICLE 4 - TRANSFERABILITY OF MEMBERSHIP INTERESTS
