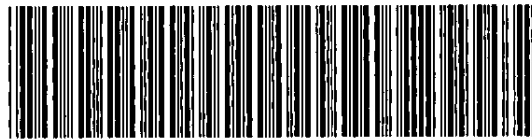

Effective Date






