**ARTICLES OF ORGANIZATION
OF
APOLLO GLOBAL CATERING - ND LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is
APOLLO GLOBAL CATERING - ND LLC (the "Company").

**ARTICLE II
ADDRESS**

The principal address of the Company is 10855 Highway 2, Tioga, North Dakota 58852.

**ARTICLE III
REGISTERED AGENT AND OFFICE**


