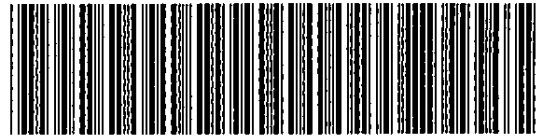

**ARTICLES OF ORGANIZATION
OF
LIGHTHOUSE LODGE, LLC**

1. Name. The name of this limited liability company is **LIGHTHOUSE LODGE, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of June 23, 2014 and shall thereafter be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 2105 Marjory Ave., Tampa, FL 33606.


6. Management of the Company. The management of the Company shall be vested in the managers of the Company. The initial manager of the Company is as follows:


