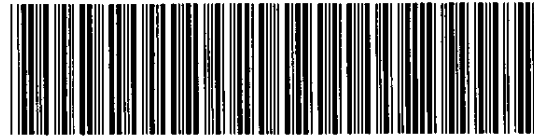

ESQUENAZI GROUP, LLC n/k/a PREMIER PLASTICS, LLC**

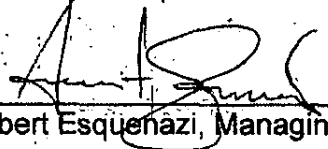
