**ARTICLES OF ORGANIZATION OF  
ATI GENERATIONS, LLC**

The undersigned, Melissa Suzanne Briscoe, a natural person competent to contract and a member of ATI GENERATIONS, LLC, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I**

The name of the limited liability company is ATI GENERATIONS, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing address and street address of the Company's initial principal office is 6351 Dunlieth Place, Pensacola, Florida 32504.

**ARTICLE III - PURPOSES AND POWERS**

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

**ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE**

**ARTICLE IX - AMENDMENT**

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Revised Limited Liability Company Act, as it presently exists or may hereafter be amended.
