**ARTICLE VI: ADMISSION OF ADDITIONAL MEMBERS**

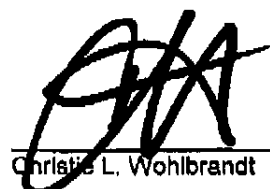
Upon approval as set forth in the operating agreement of the company, the company is authorized to issue additional Units in the company and to admit Additional Members to the Company.

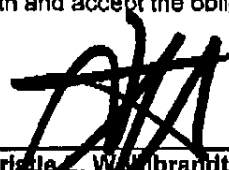
