THESE THIRD ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF ENGAGE INNOVATIONS, LLC, a Florida limited liability company, are executed by the undersigned Manager, as authorized representative of the Board of Managers, for the purposes set forth herein:

1. The name of the limited liability company is Engage Innovations, LLC.
2. The Articles of Organization were filed on June 25, 2014 and assigned document number L14000102351.
3. The Articles of Organization were previously amended on September 30, 2014 and October 15, 2014.
4. The limited liability company has approved changing the name of the company from Engage Innovations, LLC to Engage Innovation, LLC.
5. The limited liability company has adopted the following amendment to the Articles of Organization, as previously amended:

Article I, Name, is hereby amended and restated in its entirety to read as follows:

**ARTICLE I - NAME**
